Carlton Everett Herndon, beloved son of William and Iris J. Toyer, passed away July 7, 2025. Carlton was born in Washington, D.C., and was educated in the D.C. Public School system, graduating from William McKinley Sr. High School in 1987. Following graduation, Carlton attended Morgan State University for one year before returning home, as he had decided to pursue a career in law enforcement. He joined the D.C. Metropolitan Police Department and served honorably, retiring after 28 years of service. After a few years away from the workforce, Carlton returned to work as a Bailiff in the Prince George's County courts.
